How to use this scoring sheet to monitor your progress toward MAEAP livestock verification:

- Although all questions in the Livestock*A*Syst are important, only the ones that are necessary for MAEAP livestock verification are scored.
- Each question has been assigned a debit score based on its relative environmental risk.
- Circle the debit score that reflects the current farm situation. When two debits are an option, the lower debit relates to the medium risk column, the higher debit reflects the high risk column.
- Do not circle any debits if the question does not relate to your farm.
- Add up all of the circled debit scores.

What does your score mean?

This point system can be used to track progress and plan improvements as new management practices are adopted. The score might also be used to show family, farm partners, employees, customers, neighbors and other interested parties how much progress the farm has made. The higher the score, the closer the farm is to MAEAP livestock verification.
