

Michigan Agriculture Environmental Assurance Program Logo Use Terms of Agreement

Michigan Agriculture Environmental Assurance Program (MAEAP) partners encourage all MAEAP-verified farms to display the MAEAP logo proudly and professionally. A MAEAP partner or supporter, MAEAP-verified farm, or other entity (Licensee) shall use the MAEAP logo in the following manner and in accordance with the following conditions:

1. The standard MAEAP logo (Figure 1) shows the correct ratio and colors.
2. The ratio of the logo shall be: W 1: H 0.6
3. The logo may be used in a monochromatic color scheme (e.g., Figure 2 below)
4. The logo may be watermarked up to 30%.
5. If the logo is not monochromatic, the colors of the logo must be:
 - a. Blue: Pantone 661 CVC
 - i. C 100 M 69 Y 0 K 9
 - b. Light blue: 33% of Pantone 661 CVC
 - c. Green: Pantone 576 CVC
 - i. C 56 M 0 Y 91 K 38
6. The logo is to be used in a professional manner.
7. The logo may be used on apparel, letterhead, in publications and other promotional items.
8. The logo may only be used in its entirety (e.g., not cut apart).
9. If a farm is using the logo, the farm must be MAEAP verified and considered in "good standing."
10. Do not try to recreate the logo.
11. The logo can be used or placed on products or containers with products grown on MAEAP-verified farms when the farm meets the following criteria:
 - a. Is verified in two or more MAEAP systems.
 - b. Is currently considered "in good standing" with MAEAP.
 - c. Is considered to have a "current verification" and "active."
 - d. The logo must be paired with the words "Environmentally Assured Farm" (Figure 3).
12. To use the logo, the entity must first file the License Agreement with MDA.
13. Camera-ready artwork and/or an electronic version of the logo will be sent after receipt of the License Agreement.
14. MAEAP reserves the right to deny use of the MAEAP logo.
15. Additional terms. Licensee agrees to comply with and be bound by the additional terms on the following page.

The use of the logo should not be construed as validation of one farmer or product over another and does not mean that the coalition of MAEAP partners endorses the farmer or product.

1. **Grant of License.** Michigan Department of Agriculture (Licensor) hereby grants to Licensee, and Licensee hereby accepts from Licensor, the non-exclusive, non-transferable, royalty-free right and license to use the logo.
2. **Reservations of Rights.** Licensor reserves to itself all rights in and to the logo except as specifically granted herein to Licensee, and Licensor may exercise such right at any time in any manner that it may deem appropriate.
3. **Ownership of Logo.** Licensee acknowledges that Licensor is the sole owner of the logo and the goodwill therewith, and that all use of the logo by or on behalf of Licensee will inure to the benefit of and be on behalf of Licensor exclusively.
4. **No Warranties.** Licensee acknowledges that, except as expressly set forth in this agreement, the rights granted hereunder are provided without any warranty, on an “as is” basis, and that licensor is not providing any other warranties of any kind, whether express or implied, with respect thereto, including without limitation any warranties of merchantability or fitness for a particular purpose.
5. **Limitation of Liability.** Licensor will have no liability or responsibility for special or consequential damages of any kind whatsoever suffered or incurred by licensee as a consequence of the use of the marks or otherwise, even if Licensor has been advised of the possibility of such damages.
6. **Liability of Licensee.** Licensee will indemnify and hold harmless Licensor from and against any and all costs, claims, damages, expenses and liabilities of any kind (including without limitation reasonable attorneys’ fees and costs) with respect to any claims or suits brought by any third party arising out of any act or omission of Licensee, its employees, consultants or Licensees in connection with any matter whatsoever connected with or related to this Agreement, including but not limited to claims arising from Licensee’s marketing, distribution or sale of any goods or services.
7. **Assignment.** Neither this Agreement nor the license granted herein nor any other rights granted hereunder may be assigned, sublicensed or transferred by Licensee without the prior written consent of Licensor, and any attempted assignment, sublicense or transfer, whether voluntary or by operation of law, will be void and of no force or effect.
