DEADLINE FOR APPLYING: MAY 1, 2024

ELIGIBILITY

- 1. The applicant or his/her parents/legal guardian must be a member of the St. Joseph County Farm Bureau and be involved in the production of agriculture.
- 2. The applicant must be a graduate accepted by or attending a post-secondary institution. Applicant must be at least a sophomore in an ag-related study and will be continuing in that or any other agriculture related study or in their 2nd year of a 2-Year Ag Program.
- 3. Applicants may re-apply for this scholarship each year.
- 4. Student's grades and need for the scholarship are taken into consideration.
- 5. The St. Joseph County Farm Bureau Board of Directors will determine the recipient(s) of the scholarship(s).

APPLICATION PROCEDURE:

- 1. Complete all sections of the application form.
- 2. Attach a most recent transcript from the college you are currently enrolled.

- 1. Scholarship to be used for tuition, fees and books and will be paid directly to the University or College.
- 2. If the recipient of the scholarship quit or drops out of school the remainder of the scholarship is to be refunded to the St. Joseph County Farm Bureau. Students must maintain a grade point average of 2.0 or better.
